



Three Essentials for Navigating Medicaid Reform



1. Audit Your At-Risk Populations

- Identify patients who rely on Medicaid or ACA plans.
- Assess how many are dual-eligible (Medicare + Medicaid).
- Flag patients with chronic conditions (e.g., dialysis, behavioral health) who are vulnerable to coverage disruption.

2. Strengthen Communication Channels

- Ensure your team can quickly inform patients of changes in coverage, renewals, or copay policies.
- Translate materials into multiple languages as needed.
- Use smart patient TV's, patient portals, or text messaging for consistent outreach.



3. Equip Staff with Training and Tools

- Educate care teams on upcoming policy changes and how to talk to patients about them.
- Implement digital tools that reduce the time needed for paperwork, verification, and follow-up.
- Design workflows that integrate technology into routine staff tasks to ease burden.

4. Deploy Patient-Facing Technology

- Use platforms like [GENiO by PDi](#) to deliver bedside education, treatment updates, and coverage resources.
- Send messages to patient TV's to help them stay informed about exemptions, updates, and care continuity.
- Enhance engagement with entertainment, two-way communication, and feedback tools.

5. Develop a Resilience Plan

- Review financial exposure to Medicaid and ACA changes by department.
- Identify service lines most affected by reduced reimbursement or patient drop-off.
- Prepare contingency plans for maintaining care quality with fewer resources.
